The Local Development Corporation of East New York (LDCENY) is committed to accomplishing its goals as it relates to growing businesses, changing lives an strengthening communities—a motto we believe in and employ in the work we do with businesses (large or small) and individuals. Some of the highlights were:

- Assisted three local businesses in the buildings trade to receive \$3.4 million in contracts for Lavonia Commons (an affordable housing project) as part of the LDC's "Meet the Developer" workshop
- Reduced the commercial vacancy rate from 10% to 6.3% along a major retail corridor through the Avenue NYC's Business Attraction program
- Partnered with one of the largest employers in the industrial park to host a "Toy Giveaway" and Holiday Party for 99 children in the neighborhood
- Trained over 800 aspiring and current entrepreneurs through our various workshops and training sessions
 which included MWBE Certification, Writing a Business Plan, Tech Tools for Business, Social Media Strategies,
 Retail Ready, and Money Management, Entrepreneurial Assistance Program, and Sales training and
 Mentoring
- Provided One-on-one counseling sessions to over 300 entrepreneurs
